Open to all Artists of MarinMOCA. You are invited to submit one original work not previously shown in a MarinMOCA or Artists of MarinMOCA exhibition. In accordance with the exhibition theme, please submit work completed in the past year. All media is acceptable except video and film. This show is juried for awards only.

THEME FRESH

The first 2012 Artists of MarinMOCA exhibition encourages artists to submit new work. The goal is to give artists the opportunity to display their most recent projects, and even new experiments.

STAR AWARDS

The Board of Directors will announce the names of those volunteers who have made an outstanding contribution to MarinMOCA during the past year. Artwork by those “Stars” will be featured prominently in the exhibition.

SIZE LIMITATIONS

2D work: height 84in.(7ft.), width 72in.(6ft.) unframed, total weight with frame not to exceed 70 lbs.

3D work: height 84in.(7ft.), width 72in.(6ft.) X depth 36in.(3ft.), not to exceed 70 pounds (floor installation)

ARTWORK SPECIFICATIONS

All accepted works must conform to “Artwork Specifications” available on our website (www.marinmoca.org) and with the entry form online. Any work that does not meet these criteria must have a waiver in order to be juried. Waivers may be requested by contacting the Gallery Directors.

FEES

\$25 for 1 (one) piece. Diptychs/triptychs count as one piece. Make checks payable to MarinMOCA.

AWARDS

First Place artists for the 2012 members exhibitions will participate in a group exhibit in the Hamilton Gallery the following year. The juror will grant first, second, third, and honorable mentions (no monetary awards).

SALES

By submitting work for exhibit, artist authorizes MarinMOCA to sell such work for the “Show Price” on the entry form. After a sale occurs, MarinMOCA will reimburse the artist an amount equal to the “Show Price” less 30% commission to MarinMOCA. Enter NFS in “Show Price” for work that is not for sale, and supply value for insurance purposes.

LIABILITY

Work will be insured while on MarinMOCA premises. Artists leaving their work after the pick up date will be charged \$5 per day for storage. Works left beyond 30 days will be considered a donation to MarinMOCA.
